



2022 NCCPA Practice Analysis Survey Sweepstakes Official Rules

- 1. Eligibility:** The 2022 NCCPA Practice Analysis Survey Sweepstakes (the “Sweepstakes”) is open to Physician Assistants who are currently certified by NCCPA, who are legal residents of the U.S., and who have reached the age of majority in their state of residence and are physically located in the US at the time of entry. This Practice Analysis Sweepstakes is subject to federal, state, and local laws and regulations and void where prohibited by law. Employees, officers, directors, agents, representatives of NCCPA or of any of its parent companies, subsidiaries, affiliates, suppliers, partners, advertising and promotion agencies, (collectively the “Sweepstakes Entities”), and their immediate family members and those living in their household, whether or not related, and each person or entity connected with the production, administration of the Sweepstakes, are not eligible. Immediate family members include spouse, parent, child, sibling, including stepparents, children, siblings, half siblings, and all their respective spouses, regardless of where they reside.

- 3. Agreement to Rules:** By entering this 2022 NCCPA Practice Analysis Survey Sweepstakes, the Entrant (“You”) agrees to abide by the Sponsor’s Official Rules and decisions, which are fully and unconditionally binding in all respects. The Sponsor reserves the right to refuse, withdraw, or disqualify any Entry at any time at the Sponsor’s sole discretion. By entering this 2022 NCCPA Practice Analysis Survey Sweepstakes, You represent and warrant that You are eligible to participate based on the eligibility requirements explained in the Official Rules. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the conduct of this 2022 NCCPA Practice Analysis Survey Sweepstakes. **THESE OFFICIAL RULES CONTAIN A CLASS ACTION WAIVER AND LIMITATION ON LIABILITY AND DAMAGES.**
- 4. 2022 NCCPA Practice Analysis Survey Sweepstakes Period:** The Sweepstakes Period begins on June 15, 2022, with the launch of the survey and ends on July 22, 2022 at 11:59:59 pm ET. There will be Weekly Prize drawings held during the Sweepstakes Period. The Weekly Prize drawings will be held each Wednesday during the Sweepstakes Period. To be eligible to be included in a Weekly Prize drawing, your entry must be received by Sponsor by 8:00:00 am ET on the Wednesday morning of the Weekly Prize drawing (the “Weekly Prize Drawing Deadline”). If your Entry is not selected in a Weekly Prize drawing, it will remain eligible for any remaining Weekly Prize drawings held during the Sweepstakes Period. ET means the local time in New York City, NY, USA on the specified date. The Sponsor’s computer system will be the official timekeeping device for all matters relating to this Sweepstakes.
- 5. How to Enter:** To be considered an “Entrant” in the Sweepstakes, during the Sweepstakes Period, physician assistants must (a) complete the 2022 NCCPA Practice Analysis Survey (“Entry”) in compliance with the requirements of these Official Rules and (b) respond “Yes” to the “I have reviewed, accepted, and agreed to all of the 2022 NCCPA Practice Analysis Survey Sweepstakes Official Rules and want to be entered in the Sweepstakes” question at the end of the survey. To be considered eligible to win a prize, Your Entry must fully meet all Sweepstakes requirements, as specified in the Official Rules or the survey, including providing your full legal name, address, and email address for winner notification and validation in the event your Entry is randomly selected in a drawing. 7. Odds: The total number of eligible Entries received during the Sweepstakes Period determines the odds of winning.
8. Selection and Notification of Winner: Winners will be selected by random drawing under the supervision of the Sponsor. Entries received by the Weekly Prize Drawing Deadline for any week during the Sweepstakes Period will be eligible for the Weekly Prize drawing held that week and any succeeding Weekly Prize drawings remaining. At each of the Weekly Prize drawings, the Sponsor will randomly select up to ten (10) Entries from among all eligible Entries received by the Weekly Prize Drawing Deadline for that week. For each drawing, Sponsor will notify the Entrant selected as described above (each a "Selected Entrant") by email at the email address contained within the Selected Entry within five days following selection. The Sponsor is not responsible for nor shall have liability for any Selected Entrant's failure to receive notices for any reason, including email security settings that may cause notifications to be marked as spam or junk email or Selected Entrant's provision of incorrect or otherwise non-functioning contact information. Selected Entrant must respond to the prize notification email and complete and return an executed declaration of eligibility and releases of liability and publicity within the specified timeframe, or the prize may be forfeited and an alternate Entrant may be selected. Receipt of the prize offered in the 2022 NCCPA Practice Analysis Survey Sweepstakes by the Winner is upon the condition of compliance with any and all federal, state, and local laws and regulations. The Sponsor, in the event of any of the above issues, may in its sole discretion, determine Winner(s) based on all eligible Entries received prior to and/or after (if appropriate) the incident. In addition, Sponsor reserves the right to award fewer than ten (1) Weekly Prizes in any Weekly Prize drawing in the event that fewer than ten (10) eligible Entries have been received by the appropriate Weekly Prize Drawing Deadline.
