#### **Important Dates**

#### **Submission Requirements (submit in word documents)**

- -All presenter names and qualifications
- -CV of primary presenter (must register and attend Summit)
- -Title/Abstract (~300 words)
- -150 word summary of research (for brochure)
- -Primary presenter disclosure information (presenters must briefly acknowledge any commercial support of the original research presented and/or any financial interests held by the presenters).

#### **Draft of Poster:**

- -Submitted as a PowerPoint slide (.ppt or .pptx file) to a size of 48 inches x 36 inches.
- -Titles, authors, and institutional affiliations are listed.
- -Introduction/Abstract (~300 words)
- -Description/learning objectives (no more than 300 words)
- -Methods, Results, and Conclusion/Discussion
- -References

### **REPRESENT! NCCPA Summit Call for Posters**

#### **Requirements for Submission**

All submissions must include a draft of the poster to be evaluated for acceptance. Please consider the poster's accessibility (e.g., use text large enough to read when viewed from a reasonable standing distance, use simple non-serif fonts and high contrast between text and background). Posters should be in landscape orientation. For the su

Primary presenter(s) must be able to register for and attend the Summit in-person in Atlanta, Georgia and be available to present on September 16th-17th 2024.

There is no cost for registration. Attendees are responsible for all expenses including, but not limited to, travel, lodging, and transportation.

If the poster is accepted, you will be responsible for notifying co-presenters regarding the status of the proposal and the date, time and location of the presentation.

Posters will be evaluated on: anticipated interest; high-quality, a well-written description, learning objectives and processes; and practical application of material.

Ethical research: your poster submission and research approach should be inclusive and respectful.

Abstract and Poster submissions will be reviewed by the REPRESENT! Steering Committee. We reserve the right to reject without further review submissions that do not include all the required components.

NCCPA reserves the right to NOT accept a poster from any presenter/organization that it deems inappropriate or at cross purposes to the NCCPA's mission and/or the Summit objectives.
